APPLICATION AGREEMENT
Booths MUST open Saturday from 10:00a-4:00p.
No early breakdowns.

REGISTRATION: Booth fees are \$25.00 or \$15.00 and are non-refundable. This is a juried event. Booths will be confirmed no later than October 12th. All fees will be refunded if application is not accepted. Booth sizes are 6’x6’ and 8’x10’ open spaces. Exhibitors must stay within the perimeters of the assigned booth to avoid interference with other booth spaces. Electricity is limited and requires an additional fee of \$10.00 IF available. Booths are “open space” only and Exhibitors are responsible for their own tables, chairs, etc. **Registration forms AND a minimum of 3 product photos (jpeg format) must be emailed to ajohndrow@lvpoa.org** Payments may be mailed, paid online @ www.lvpoa.org or dropped by the POA Admin Office @ 20503 Dawn Dr, Lago Vista, TX 78645. Payment must be received in order to consider application. If not approved as a vendor all payments WILL BE REFUNDED.

SET UP: Set up is **Friday, November 9th, 4:00p-7:00p** AND **Saturday, November 10th, 7:30a-9:30a**. Loading/unloading will be in designated areas only. Exhibitors must park in designated “vendor” area.

CANCELLATIONS: Exhibitors are expected to contact the LVPOA Event Coordinator, ajohndrow@lvpoa.org as soon as it becomes apparent that a cancellation is needed. We appreciate as much notice as possible, so we can provide a space for another potential exhibitor.

SUBLETTING BOOTHS: Exhibitors will not give, sell or lend any space allocated to them. Exhibitors may share a booth upon approval from LVPOA Event Coordinator.

BOOTH ATTENDANTS: Each Exhibitor must keep an attendant at the display during the Bazaar hours. All attendants must be representatives of the Exhibitor. The Exhibitor will keep the occupied space in good order. Each Exhibitor will be responsible for assuring safety and security in and around their booth in a manner that minimizes risk or hazards to the public. All items must be kept within the Exhibitor’s designated space. NO sales or solicitation outside of the booth space will be allowed. Vendors should plan ahead for cash sales. Wi-Fi connection is not available. AT&T hot spot works best, but be aware of your provider’s data charges.
